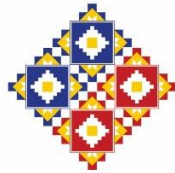

## Annex 1 – Maps, municipalities of programme area and thematic priorities



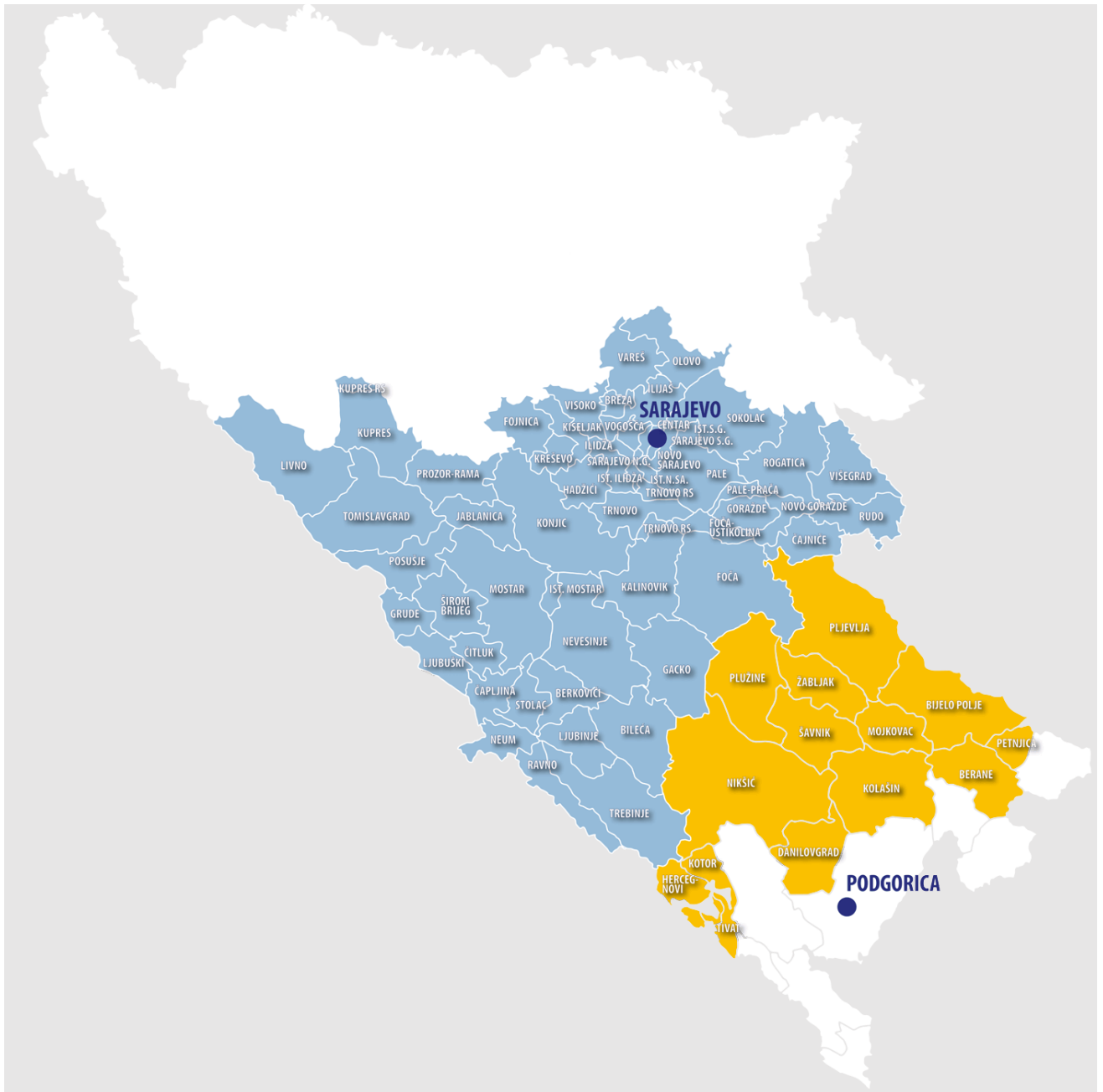
